- 7. Acceptance would be announced by 31st August 2022

[All submissions will be subject to blind review by two independent reviewers. Papers are accepted for publication subject to no substantive, stylistic editing. A copy of the edited paper along with the first proofs will be sent to the author for proof-reading *if* select for publication.
